  - CMR copy upload
    - Browse and upload
    - Max size – 20 MBs
    - Formats – jpg, pdf, jpeg, png
- If any mandatory field is not filled, user will be shown message - Some mandatory details are missing, please recheck. This message will be shown on click of submit button and placement will be just above the CTA – Submit

- After receiving the documents on portal, the DP Operations team fetch the documents for processing, if the documents are valid they will process the request and after processing the request the intimation of the same will be sent to the clients on their registered email id within the TAT of 5 days.
